Bipartisan Infrastructure Law Overview


In November 2021, President Biden signed into law the Infrastructure Investment and Jobs Act (IIJA – the bipartisan infrastructure law) nearly \$1 trillion for building roads and bridges, expanding broadband, and upgrading public transit, utility, and energy systems.



GMA BIL Updates:

Georgia BIL minimum funding

- \$8.9 billion for roads
- \$225 million for bridges
- \$100 million for broadband
- \$1.4 billion for public transportation
- \$619 million for airports
- \$8 million for the Port of Savannah
- \$135 million for resilient infrastructure

- Overburdened by pollution



“All Justice40 covered programs are required to engage in stakeholder consultation and ensure that community stakeholders are meaningfully involved in determining program benefits. Covered programs are also required to report data on the benefits directed to disadvantaged communities.”





Tools and Resources


- The Climate and Economic Justice Screening Tool (CEJST) is a geospatial mapping tool to identify disadvantaged communities that are marginalized, underserved, and overburdened by pollution.
- Interim Justice40 Implementation Guidance was issued by the Office of Management and Budget (OMB) in July 2021.

- Roads, Bridges, and Major Projects - \$400 billion
- Passenger and Freight Rail - \$66 billion
- Public Transportation - \$91.2 billion
- Airports and Federal Aviation Administration Facilities - \$25 billion
- Ports and Waterways - \$16.7 billion
- Safety - \$38 billion
- Electric Vehicles, Buses, Ferries - \$7.5 billion

Clean Energy and Power

- Delivering clean power - \$21.3 billion
- Clean energy demonstrations - \$21.5 billion
- Energy efficiency and weatherization retrofits for homes, buildings, and communities - \$6.5 billion
- Funding for clean energy manufacturing and workforce development - \$8.6 billion

Water

- Drinking Water and Clean Water State Revolving Funds - \$23.43 billion
- Lead Service Lines - \$15 billion
- PFAS and Emerging Contaminants - \$10 billion
- Indian Water Rights - \$2.5 billion
- Indian Health Service Sanitation Facilities Construction - \$3.5 billion
- Water and Sewer Tax - \$1.25 billion
- Western Water including Rural Water - \$8.3 billion

Resilience - \$50B, including:

- Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation (PROTECT) Grants - \$8.7 billion
- Wildfire Management - \$8.25 billion
- Investments in Resilience through the Army Corps of Engineers - \$7 billion
- Western Water - \$3.8 billion
- Flood Mitigation Assistance Program - \$3.5 billion
- Weatherization - \$3.5 billion
- Cybersecurity - \$1.3 billion

Environmental Remediation

- Abandoned mine land reclamation - \$11.3 billion
- Orphaned well plugging, remediation, and restoration - \$4.7 billion
- Superfund site cleanup - \$3.5 billion
- Brownfield remediation and revitalization - \$1.5 billion

(Broadband)**

Focuses on closing the digital divide, access, and cost through:

- Broadband Equity, Access, and Deployment Program - \$42.45 billion
- Affordable Connectivity Program - \$14.2 billion
- Digital Equity Planning, Capacity, and Competitive Grants \$2.75 billion
- Tribal Broadband Connectivity Program - \$2 billion
- Rural Broadband Programs at the Department of Agriculture - \$2 billion
- Middle Mile Grant Program - \$1 billion
- Private Activity Bonds - \$600 million
